### Safety Access Control:

Any soiled #6 polystyrenes can be processed - trays, cups, clamshells and utensils. The briquettes are converted into PS pellets or styrene oil for repurposing. In a two year period StyroGenie has diverted over 97,000,000 polystyrene trays from landfills and we will keep counting.

### Short Form Specification:

Constructed with 16 gauge type 304 #4 polished stainless steel interior and exterior with front facing opening single door with 3 stainless steel hinges. Door(s) to have timed safety interlocks. Will have 2 removable 14 gauge stainless steel catch pans with hemmed edges. Cabinet will be vented through interior sidewall and terminated into stainless steel collection cup. Will be controlled by intuitive pass code protected LED Command Center Touchscreen with step by step instructions for safe loading, processing and unloading. Capacity will be 1800 polystyrene foam trays with maximum 8 hour processing time and pass code safe to "Open Doors" button for unlocking door(s). Will have a 4 digit pass code to prevent unauthorized access and operation. Will have redundant high limit temperature sensors to prevent overheating with "Safe to Open" message from Command Center. It will be listed and labeled by Intertek. 120v, 18.8 amps. 25 amp circuit minimum, 8 foot cord and NEMA 5-30P plug. Castors or legs.

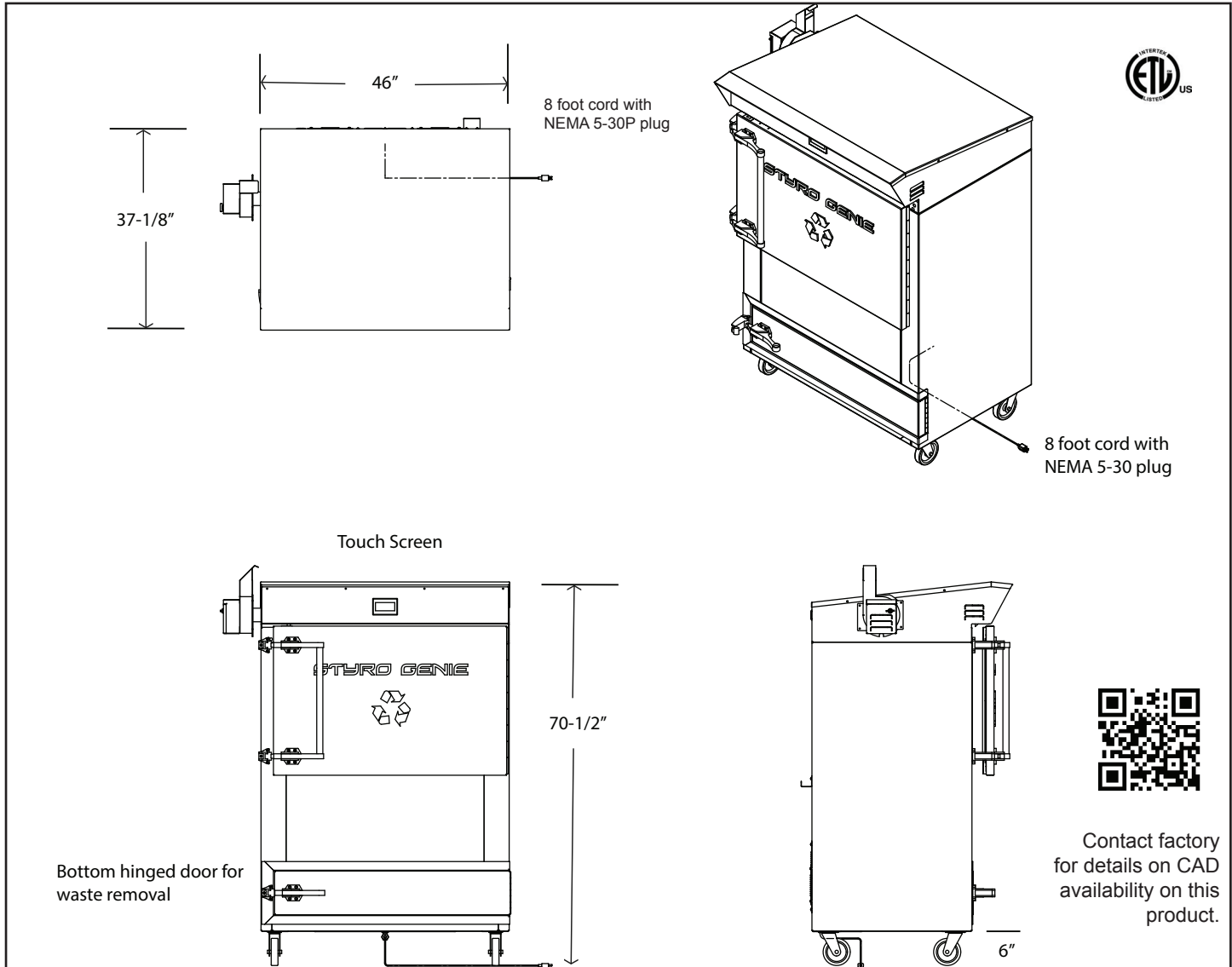
